GP.23.01 Presentation of Fitness Coaching Proposal

A resident gave a presentation on a proposal to provide outdoor fitness sessions on the playing field and/or Pavilion car park during the spring and summer months (weather permitting), as follows:

- All equipment would be provided (barrels, tyres, etc);
- Storage would be required for equipment although this need not be under cover;
- Appropriate certificates of qualifications and public liability insurance would be provided, as required;
- A charge would be made to those attending the sessions;
- Access to the Pavilion for toilet facilities would be appreciated.

Action/Comments Agreed:

Members agreed to recommend to full council that this initiative be supported with the following conditions:

- Offer a 3-month trial period free of charge;
- After the trial period, charges might be applied for water and cleaning costs if the Pavilion was used;
- Open storage could be provided in the compound behind the Pavilion although no responsibility could be accepted for damaged or stolen items;
- Certificates of qualification to be provided;
- Certificate of Public Liability Insurance to be provided.


Members reviewed the second draft of the Health & Safety Policy drafted on 14th March 2023.
